



# CAS International Tax Law Comparative Law 2019/20

## Programme overview

The two-semester programme includes 7 modules, which are divided into one mandatory module and 6 complementary modules. The participants choose complementary modules with a scope of 14-15 ECTS. There are complementary modules with a total of 18 ECTS available for selection. The sessions are held in the spring semester 2019 (from January to mid-June) and the fall semester 2019 (from end of August to December), generally on a two-weekly basis both on Fridays (full-day) and Saturdays (until 3pm). Graduates will receive a Certificate of Advanced Studies (18 ECTS Credits) from the University of Zurich. The ECTS can be used as a credit for a later participation within the LL.M. Programme 2021/22 of the University of Zurich.
